Charges and Exemptions

Landing Charges

ICAO VORTEX CLASSIFICATION	MTOW	CHARGE
Light	Up to 7,000 Kg	BD 7.000 flat rate
Medium	7,001 up to 136,000 Kg	BD 1.400 per 1,000 Kg or part thereof
Heavy	Over 136,000 Kg	BD 1.500 per 1,000 Kg or part thereof

Exemptions

- Aircraft undertaking flights shortly before departure from Bahrain solely for the purpose of ensuring that the aircraft, its engines and instruments are serviceable, and when approved in advance by the airport authority.
- Military aircraft of the GCC.
- Royal, diplomatic and state aircraft, on a reciprocal basis, and provided no fare-paying passengers are carried.
- Aircraft engaged on search and rescue operations when providing a free service.
- Aircraft undertaking flights on behalf of the airport authority for the calibration or checking of the airfield.

Freighter Operations

50% reduction on landing en-route charges, and available on flat rate.

Parking Rates

MTOW	RATE
Aircraft up to 25,000 Kg	Flat rate BD 5.000
Aircraft of 25,001 Kg & over	BD 0.200 per 1000 Kg or part thereof

No parking fees will be charged for the first two hours after landing. After the first two hours and for each period of 24 hours or part thereof the above parking rates will be charged.

Exemptions

The same as for exemption from landing charges

Standard Charges:

charges impose on each landing and take-off to / from Bahrain international Airport.

40,001 Kg – 80,000 Kg	BD 18.900
80,001 Kg – 120,000 Kg	BD 25.200
120,001 Kg – 200,000 Kg	BD 31.500

300,001 Kg or more	BD 42.000

EN-Route Charges

Air Navigation charges for aircraft that does not landing in Bahrain international Airport.	
Weight	Charges
Up to 40,000 Kg	BD 24.000
40,001 Kg – 80,000 Kg	BD 35.000
80,001 Kg – 120,000 Kg	BD 47.000
120,001 Kg – 200,000 Kg	BD 59.000
200,001 Kg – 300,000 Kg	BD 71.000
300,001 Kg or more	BD 79.000

Exemptions

- a) Military aircraft used for military purpose by GCC.
- b) Aircraft being used for Bahrain Government ceremonial purposes.
- c) Test flights.
- d) Training flights carried out in an Aerodrome Control Zone.
- e) Aircraft providing Search and Rescue services free of charge.
