## **GUIDANCE NOTES ON THE COMPLETION OF FORM ALD/AIR/F127**

### **Note 1 – Application for the Issue of Certificate of Airworthiness for Export**

The Certificate of Airworthiness for Export certifies that the aircraft is airworthy at the date of issue of the Certificate and does not constitute authority to operate the aircraft.

### **Note 2 – Engine Details**

Include here the manufacturer and the full designation number of the engine type. Applicants are advised to ensure that engines comply with mandatory airworthiness requirements applicable, and are acceptable to the importing airworthiness authority.

### **Note 3 – Propeller Details**

Include here the manufacturer and the full designation number of the propeller type and ensure the engine/propeller combination is in compliance with the mandatory airworthiness requirements applicable, and are acceptable to the importing airworthiness authority.

### **Note 4 – Aircraft Permit to Fly**

When requested, a Permit to Fly for Ferry Purposes may be issued to enable the aircraft to be delivered to its destination. This will normally be issued for a strictly limited period only. Aircraft holding a current, valid Bahrain CAA Certificate of Airworthiness need not request a Permit to Fly for ferry purposes.

### **Note 5 – Importing country**

Some Airworthiness Authorities require Special Requirements to be embodied before an aircraft may be issued with a Certificate of Airworthiness. It is the responsibility of the applicant to ascertain these import requirements and ensure they are made available to Bahrain CAA. The applicant should also obtain confirmation from the importing Airworthiness Authority of anytime limitations associated with the issue of the Certificate of Airworthiness for Export.

### **Note 6 – Derogations**

A condition for the issue of Bahrain CAA Certificate of Airworthiness for Export is that the aircraft must qualify for the issue or renewal of a Bahrain CA A C of A. Any derogation from this standard required by the importing Airworthiness Authority must be notified in the application form. The applicant must obtain written acceptance of these derogations from the Airworthiness Authority of the importing country and forward this acceptance to Bahrain CAA.

### **Note 7 – Place of Survey**

A Certificate of Airworthiness for Export shall only be issued following a survey of the aircraft and its documentation by Bahrain CAA. Where the survey is to be carried out overseas, the applicant must confirm in writing that they accept all additional related costs.

### **Note 8 – Avionic Systems**

The applicant shall enter the name of the manufacturer, the system type number and the number of such systems installed. Delete those systems where no equipment is fitted. Where equipment required by the importing country is installed.

If no auto-pilot is fitted state None. If no radio equipment is fitted state None.

### **Note 9 – Declaration**

The current registered owner must sign where indicated to signify their consent to a Certificate of Airworthiness for Export being obtained. A third party may not sign on their behalf without written consent from the current registered owner. The application cannot be processed without appropriate authorisation, and in correct or incomplete information will delay its progress.
