- 5. Original Valid CPR of owner
- 6. Fixing of name plate and side registration numbers
- 7. Passing of inspection
- 8. Confirmation of approved installation of Automatic Identification System (AIS)
- 9. Valid fishing permit (in case of fishing boat)

#### Requirements for Renewal / Cancellation of Registration

- 1. Filled and signed application form (with stamp for Companies)
- 2. Original boat's registration certificate
- 3. Original Valid CPR of owner
- 4. Surrender of boat's plate (for cancellation requests)

#### Main Requirements for New Registration of Jet ski

- 1. Filled and signed application form (with stamp for Companies)
- 2. Original builder's certificate
- 3. Original deletion certificate and bill of sale (for Imported Jet Skies)
- 4. Customs declaration for (Imported Jet Skies)
- 5. Original Valid CPR
- 6. Clear photos of the Jet Ski (including serial number)
- 7. Confirmation of Jet Ski's side numbers
- 8. Passing of ski inspection
- 9. Valid insurance cover certificate (for Companies Only)

#### Transfer of boat/jet ski ownership

- 1. Filled and signed application by seller and buyer (with stamp for Companies)
- 2. Original boat/jet ski registration certificate
- 3. Original Valid CPR of the buyer and the seller
- 4. Surrender name plate (in case changing the boat's name)

#### Requirements for Renewal of jet ski registration

- 1. Filled and signed application form (with stamp for Companies)
- 2. Original Jet Ski registration certificate
- 3. Original Valid CPR
- 4. Valid insurance cover certificate (for Companies Only)

#### Requirements for New Navigational Permit

- 1. Filled and signed application form (with stamp for Companies)
- 2. Original Valid CPR:
  - 1- The applicant must be at least 18 years old.
  - 2- For Non-Bahraini nationalities the registered occupation must be (Boat Driver) along with the sponsor's name.
- 3. Original valid boat registration certificate
- 4. Valid fishing license (for Fishing Boats)
- 5. Sign declaration form of safety requirements
